For example, the CIT has worked hard to train people to use technology to access remote meetings during the COVID pandemic. The team will continue to offer the opportunity to join meetings remotely, meaning those who cannot attend physical meetings, be it because of mental or physical health, or time constraints on the travel involved. The CIT will always look to be innovative, ensuring the widest possible involvement and inclusivity.
